### The Geopolitics of Clean Energy: A Focus on Lithium

### The Security-Sustainability Nexus: Lithium Onshoring in the Global North

– In this article, the author examines the political economy of lithium and emphasizes two major developments. First, the onshoring of lithium mining by Global North governments to enhance supply chain security; and second, a clear commitment to sustainable sourcing. The author theorizes these trends within a "security–sustainability nexus" that aligns state and corporate interests. However, this alignment reveals contradictions in green capitalism and the persistent inequalities within extractive industries amid the energy transition, Global Environmental Politics. Washington Wants a White Gold Rush – The Biden administration, through the Inflation Reduction Act and significant domestic investments, aims to reduce dependency on China for lithium—a critical mineral for US green technologies. Efforts include incentivizing new projects, particularly in Nevada, though the author notes that challenges remain, such as environmental concerns, labor shortages, permitting issues, and volatile lithium prices, Foreign Policy. Steps Forward to Strengthen the Lithium-Ion Battery Supply Chain – In this article, the author puts into perspective the Biden administration's approach to reshoring and reducing supply chain risks as part of the green energy transition. **Driving Change: How are EVs reshaping China's economic relationship with Latin America?** – This brief examines China's increasing dominance in Latin America's EV supply chain, fueled by substantial investments in lithium, copper, refining, and vehicle assembly. Chinese engagement is bolstering its EV industry while reshaping Latin America's economy and environmental landscape, raising questions about the region's economic advancement and sustainability, *Council on Foreign Relations*. What US tariffs on Chinese batteries mean for decarbonization—and Taiwan – In this policy brief, the author urges a balanced U.S. approach to Chinese-made batteries, advocating for cooperation with allies to address security risks without compromising decarbonization goals. Recommendations include diversifying supply chains, particularly for critical materials, enhancing grid resilience, and expanding U.S. battery manufacturing and infrastructure to reduce reliance on China, *Atlantic Council*.
